

Typical Processing

- 1. Add to wastewater adjusted to pH of 8-10 (typical with sodium hydroxide) 5 ppm of P-424 to treat 1 ppm of PO4 (use with Poly Lyte 1225-AL)
- 2. Use vigorous mixing when adding to your waste water. Mixed solutions can be held for long periods to control costs.
- 3. Bench test or jar test for your particular needs.
 - "do not add to process tanks in-line"
